BACK TO SCHOOL

Kohler Pension Benefits if you “die” prior to retirement

The plan provides a benefit to your spouse, or non-spousal beneficiary for unmarried participants who have 20 or more years of benefit service, if you die before retirement.



If you have been married for at least 12 months, the plan provides a lifetime pension benefit to your spouse if you die after you are vested in your plan benefit, but before

you start receiving payments. This coverage is automatic.

“If you die after attaining your earliest retirement age, the benefit amount is equal to 50% of the lifetime benefit you would have received under the plan's single-life annuity option, assuming you retired under a single-life annuity option on the day before your death. If you die while employed by the Company but prior to your earliest retirement age, the benefit amount is equal to 50% of the lifetime benefit you would have received under the plan's single-life annuity option assuming you terminated employment on your date of death, survived until your earliest retirement age, and died the following day. If you die after terminating employment but before attaining your earliest retirement age, the benefit amount is equal to 50% of the lifetime benefit you would have received under the plan's single-life annuity option assuming you had survived to your earliest retirement age and died the next day.

If you are unmarried (or married for less than one year), and have earned 20 or more years of benefit service, you may designate a non-spousal beneficiary who may receive a pre-retirement death benefit in the event of your death prior to retirement.

The benefit amount is equal to 50% of the lifetime benefit you would have received under the plan's single—life annuity option making the same assumptions described above.

****Important note: A pre-retirement survivor benefit will not be paid on your behalf if a valid beneficiary designation is not on file with the plan administrator when you die and you do not have an eligible surviving spouse. It is your responsibility to keep the plan administrator up-to-date regarding your marital status and beneficiary information.** You may change your beneficiary at any time by submitting a new Pre-Retirement Survivor Annuity Designation Form available through Corporate HR Services. You may contact Corporate HR Services at 920.457.4441 extension 74900 option 1, option 6.

Did you know?

A change to coverage under Kohler United Healthcare for preventive Colonoscopy's, including Cologuard, is for ages 45 – 75; if billed as preventative.

Cologuard, Fecal DNA, is once every three years. If they did find something and then wanted to do a colonoscopy, they would bill the colonoscopy as medical and it would apply to the medical benefits. The colonoscopy would not be billed as preventative.

Short-term Disability-Covid

You have tested positive for Covid (home tests not accepted) by a facility. Now what? Contact Kohler 920-457-4441 extension 74900 option 1, option 1. This is the contact number to receive disability paperwork. They will email or mail a hard copy to you. To ensure you receive the correct paperwork you should share that you received a positive covid test (home tests not accepted). You will have to share the positive Covid test with Kohler. The CDC guidelines for Covid is you can leave isolation after five days. The first three days are unpaid, the next two days would be paid. If you are out more than five days you will have to see a doctor for disability.
