On April 28, 2022, Workers' Memorial Day was observed to remember workers killed or injured on the job and to renew the fight for strong safety and health protections. Workplace injuries and deaths are on the uprise. On the average there are 275 workers daily in this country who lose their lives. In 2021 5,333 workers were killed on the job and another 95,000 died from occupational diseases.



Employers reported 3.5 million work-related deaths, injuries and diseases in 2021. According to the Strategic Organizing Center, Amazon alone accounted for 34,000 serious injuries in its warehouse.

International Workers' Memorial Day brings together workers and their representative from all over the world to remember the dead and fight for the living.

Did you know?

When on leave for workers' compensation injury or disability Kohler runs FMLA concurrent to these leaves. An employee who works for a covered employer must meet three criteria in order to be eligible for FMLA leave. The employee must:

- Have worked for the employer for at least 12 months
- For federal FMLA leave have at least 1,250 hours of service in the 12 months before taking leave and
- Work at a location where the employer has at least 50 employees within 75 miles of the employee's worksite.

The 12-month period during which an eligible employee may take job-protected family medical leave is based on the calendar year running from January 1 through December 31.

Did you know?

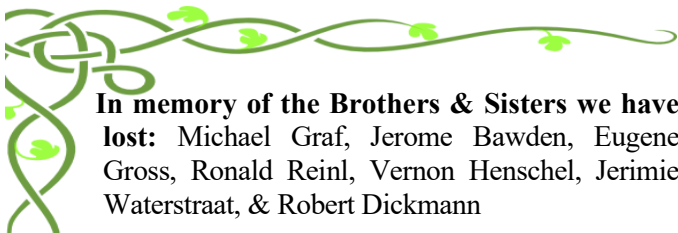

Did you know?

Over 1,000 CNH Industrial workers in Racine, Wisconsin, and Burlington, Iowa, have gone on strike. CNH is the manufacturer of Case and New Holland construction equipment.

The current six-year labor agreement at both the Burlington (UAW Local 807) and Racine (UAW Local 180) facilities expired at midnight on April 30, 2022. Following expiration of the prior agreement on April 30, UAW bargainers agreed to extend the current agreement with an hour-by-hour basis for the two facilities. On May 2, the parties set a deadline of noon CST. Upon reaching the deadline with no agreement in place that met the demands and needs of the workers, both plants went on strike.

The United Auto Workers union said in a statement. “Our members at CNHi strike for the ability to earn a decent living, retire with dignity, and establish fair work rules,” Chuck Browning, Vice President and director of the UAW’s Agricultural Implement Department said. He said the workers were committed to bargaining until goals are achieved.
